CONDITIONS OF ENTRY

- EA Dressage Rules & Official Procedures for Dressage Competition as at the 1/1/26 (and subsequent amendments), EA General Regulations (update 1/7/26)
- All Horses & Riders must be registered with EA
- All riders must have contact details on their stable for emergency
- Only ride when steward is present
- The [EA Dressage Rules and Tests](#) and [FEI Dressage Tests](#) may be download form the EA & FEI websites.
- Competitors are advised to be aware of the Rules.
- ***The onus is on riders to know the rules under which they compete.***

MEMBERSHIP & HORSE REGISTRATION

- Horses must have a current dressage EA dressage competition license; horses, owners and riders must be registered and financial with EA or, if from overseas, with their National Federation.

- Horses and rider must compete under their full registered name. Please enter with the name you have on your membership: eg: Deborah not Deb this is a major problem with the entry check and qualification checks. The Organising Committee reserves the right to abbreviate a horses' name for printing purposes. All horses are required to be micro-chipped as per national rules.
- FEI recognition Card. Minor events: (CPEDI2*/ CPEDI1*) require National Passport approved by the FEI, as a means of identification and to establish ownership. (FEI Gen. Regs. Art. 137). EA National Passport documents are available from the EA National office. Riders must ensure that they have appropriate documents on arrival. - Sampling procedure for Prohibited substances: Horses may be subject to sampling for Prohibited Substances in accordance with EA and FEI Rules.
- Anti-Doping: Human testing may take place. Ref FEI/EA Policy on [Clean Sport](#)

WITHDRAWALS (SCRATCHING) AND REFUNDS POLICY

- During the event, all competitors who withdraw from a competition must complete a withdrawal form, have the relevant officials sign the form and hand it to the Competition Office. Forms are available from the Competition office. A withdrawal (scratch) fee of \$50 per horse will apply
- Refunds: Entry fees will be refunded in full (less the administration fee) as soon as possible for withdrawals (scratching's) before the closing date. Entry fees will not be refunded after closing date unless a medical or veterinary certificate is produced within three days of the event end. In such cases, 50% of the entry fees will be retained by the OC. Entry fees (inc. stabling/camp/ etc not used) for riders on the reserve list who are not offered a start in a competition will be refunded after the event. Refunds for stables and camping will not apply for riders who decide to leave early. There will be no refunds for withdrawals after Friday 23rd February (five days before the start of the event, Rule 4.3)
- The administration fee will not be refunded

OBJECTIONS & APPEALS

- -Refer FEI Gen. Regs Arts. 163,165,166,167. Must be in writing and accompanied by a deposit of 150 SFR (approx. \$260 AUD)

SADDLERY & EQUIPMENT

- **Horse Identification/bridle numbers** (two) must be always worn when the horse is outside its stable. The Organising Committee will issue all horses with a temporary bridle number for the duration of the event. This will be available on the acceptance list.
- **All Rider must check current rules-** The [EA Dressage Rules and Tests](#) and [FEI Dressage Tests](#) may be download from the EA & FEI websites.
- Advertising and Publicity on Athletes and Horses (National) or FEI General Regulations, Article 135 - Advertising on Athletes and Horses and Promotion

FREESTYLES

- Virtus Riders require 60% average score from the two tests competed. Only the movements up to and included in the current tests at the level being ridden may be shown. Read section 8 of the EA Dressage rules for further advice in preparing freestyles.
- Equality of scores: if two competitors receive the same final score, the one with the highest marks for artistic presentation is the winner.
- There will be allocated time on Saturday at the end of the day for qualified riders to listen to there freestyle (Un Mounted)
- Freestyle Music: Music check times will be allocated on website. All music is to be submitted to this link. <https://horsesporttechnology.au/uploads/>

PRESENTATIONS & PRIZE MONEY

- Presentations will take place at the second day and third day of the completion of each competition (depending on daily program and the competition). A presentation schedule will be available on the website and posted on the notice board in the Event Office at the commencement of the Championships and updated as required. Presentations (are un-mounted) owners are welcome.
- Participation in the prize-giving ceremony of placed rider/horse combinations is compulsory. Failure to do so will result in combination losing the classification (rosette, prize in kind, prize money).

ACCREDITATION & TICKETING

- **Accreditation/Ticketing:** Will be allocated as follows: **One pass per rider, one pass per groom, one pass for the registered EA horse owner. There will be tight control of wrist bands issued at this event. One groom per horse applies for the duration of the event and no swapping permitted.**
Riders who scratch before the start of the event are not entitled to any competitor privileges or passes.

STABLING, CAMPING

- Stabling will be on entry portal open 9th January <https://carltonperformancehorses.com.au>
- Stabling is to be booked **online** whilst doing online entries when entries open.
- Stable costs, see table on last page
- All stables have rubber flooring. We suggest you order a minimum of 4 x bales of Shavings per stable.
- Extra bedding can be purchased at the venue.
- A stable bond of **\$200** will be charged at time of entry. Stables left unclean on departure will incur a \$200 cleaning fee, stables left swept clean on departure will receive a refund
- **Tack Rooms** are available for this event
- No temporary yards of any kind are allowed
- **Fodder can be ordered from:** Bishops Milton Ph: 02 4455 1344
- **Arrival of Horses:** Willinga Park will be open for arrival of horses from **Tuesday 24th 2:00pm**
- Camping facilities: These are available on the grounds. Powered sites are available and must be booked at time of entry.
There are excellent shower and toilet facilities with hot and cold water. All toilets and showers are unisex.
There are amazing rider facilities including a swimming pool, BBQ area, washing machines and dryers. All camping vehicles must have an approved 15-amp lead connecting to power outlets. One lead per powered outlet only (double adapters not allowed)

OTHER/GENERAL INFORMATION

- **Callers:** No Callers unless a commander is approved on FEI master list.
- **Speed limits** must be always adhered to.
- **Electric Scooters:** **Must be ridden responsibly: Children under 18year MUST wear safely Helmet**
- **Only designated parking areas can be used.**
- **Horses are not to be tied up to floats or trucks unless using twine and are supervised**
- **Alcohol must not be consumed by anyone subsequently riding**
- **Smoking is prohibited in the stable area**
- **Children under 14 years must be under strict supervision, at all times.**
- **Horses must be led along laneways not the main drive**
- **Cars and vehicles are not allowed on horse laneways.**
- **Please be aware that all fences are electric.**
- **Dogs** – Willinga Park does allow dogs, but they must be on a lead and, in the care of a responsible person at all times. Please clean up after your dog, & **no dangerous dogs**. Fines will apply for non-compliance (\$120 for the first offence, 2nd offence owners will be asked to remove their dog from the venue). No dogs allowed on arenas. Willinga Park recommend dogs be vaccinated against ticks
- **The serving of alcohol to underage persons is not permitted.** Competitors have a responsibility to ensure that grooms or family members under their care are supervised.
- **Indemnity:** Riders and/or owners whose entries have been accepted, undertake to indemnify the Committee against all claims, losses, suits, and damages made against or suffered by the Committee by reason of any negligent act or omission on the part of any riders, trainers or attendants whilst they are attending, riding or otherwise handling a horse, and agree that any act or omission on the part of such riders or attendants found in any action against the Committee to be negligent, shall be deemed to have been negligent for the purpose of any claim under this indemnity. Riders are required to electronically sign the Declaration form included in the entry section. **Indemnity:** Neither the Organising Committee (CPH Pty Ltd) Event Director, Equestrian Australia,

Willinga Park, accept any liability for any accident, damage, injury or illness to horses, riders, grooms, owners, ground spectators or any other person or property whatsoever. All competitors, in entering, undertake to accept this regulation.

- **Medication Control: Horses:** will be conducted under the EA Medication Control Policy (2018) and the FEI Equine Anti-Doping and Controlled Medication Regulations.
- **Insurances:** competitors have some personal accident and public liability insurance as part of their membership of Equestrian Australia.

All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents, or their horses. They are, therefore, strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.

All riders are advised to belong to a private health fund.

HORSE VACCINATIONS & BIOSECURITY

- **Vaccinations:** are recommended for Hendra virus, particularly those that reside in high-risk Hendra areas. We also recommend horse vaccinations for Strangles and Tetanus are up to date -**Biosecurity -Horse Health Declaration:** Information will be sent with Rider Information Document after close of entries
- -NSW DPI Tick & Fire Ant information will be provided within Rider Information documents closer to the event

WELFARE OF THE HORSE – FEI CODE OF CONDUCT

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to always acknowledge and accept that the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.

Horses and athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.

Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.

Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia, and retirement.

The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

EA General Codes of Conduct: EA Members should be aware of the EA Codes of Conduct for competitors, officials, and EA Members. Refer the EA web site for more information www.equestrian.org.au

Willinga Park Code of Conduct: Willinga Park is an exclusive, private facility and in the interests of ensuring the enjoyment and safety of all users the following code of conduct applies. Management at Willinga Park can use discretion at any point in time to determine access to the facilities and are not limited to the code below.

Insurance: All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents, or their horses. They are therefore strongly advised to take out a third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.

A person must not do any of the following whilst at Willinga Park.

Use indecent, obscene, insulting, or threatening language.

Behave in an offensive or indecent manner

Cause serious alarm or affront to a person by disorderly or unsafe conduct.

Obstruct a person in the performance of that person's work or duties.

Willinga Park management do not tolerate the use, transferring or in possession of any non-prescribed illegal drug will be ejected and may be handed over to the police.
